Dear Mr Coleman,

Following consultation regarding the fee structure for remedial massage therapists earlier in 2008, WorkCover NSW have gazetted the fee schedule for 2009. Indexation of fees, based on changes to the Wage Cost Index, for remedial massage therapists will occur on the 1 January each year. The table below outlines the Workers Compensation (Remedial Massage Therapy Services Fees) Order 2009 that commence 1 January 2009.

Table 1: Fees for WorkCover approved Remedial Massage Therapists from 1 January 2009

Payment Code	Type of Treatment	Maximum amount (\$)
RMA 001	Consultation and treatment (60 minute duration)	63.40 (excl GST)
RMA 002	Consultation and treatment (45 minute duration)	47.60 (excl GST)
RMA 003	Consultation and treatment (30 minute duration)	31.70 (excl GST)

Only remedial massage therapists who have WorkCover approval to provide remedial massage therapy services will be eligible for payment for remedial massage therapy services provided to injured workers. This will provide consistency in the quality of treatment provided that is more reflective of the standard set for WorkCover approved remedial massage therapists.

With these changes, non-approved remedial massage therapists will not be eligible to receive payment for services to injured workers. No new treatment plans for non-approved remedial massage therapists will be approved in 2009.

WorkCover would appreciate your communicating the new fee structure to your membership to ensure that all practitioners are aware of the changes.

At present, over 700 remedial massage therapists are WorkCover approved. These practitioners will receive information regarding the changes to fees. The Guidelines for Remedial Massage Therapists will be updated early in 2009 and provided to you for comment.

All remedial massage therapists who are approved by WorkCover are required to attend the WorkCover Outcomes Training Course within six months to maintain their approval status. This course contains valuable information regarding the workers compensation system in New South Wales, evidence based practice and outcome measures. This course is presented by Dr Sandra Grace on behalf of WorkCover at four venues during the year (see attached schedule for 2009). The following modules are covered during the course:

- (1) Organisation Setting the scene the Workers Compensation System
- (2) Evidence Evidence-based practice
- (3) Outcomes Outcome measures
- (4) Communication the remedial massage therapist's role within the workers compensation system
- (5) Resources.

A number of attendees have asked about continuing professional development (CPD) points for this course and I request that this course be considered for inclusion in your organisation's CPD program.
